Scope and Purpose: This contract supersedes and replaces any previous understanding, agreement or contract, written or verbal, between 7rendered and the contracting party (hereafter referred to as The Client). The purpose of this contract is to protect both The Client and 7rendered. The day of the event is no time for misunderstandings and oversights to surface, and this contract seeks to alleviate this possibility.

Reservation of Time and Date: This contract constitutes an order for a wedding DVD. Upon execution of this contract and receipt of the date reservation fee of \$500.00, 7rendered will reserve the time and date agreed upon. If the payments are not received by 7rendered, 7rendered may cancel the reservation without further notification to The Client (verbal or otherwise).

Changes: 7rendered will make reasonable effort to work with The Client should changes occur. If the event is rescheduled, and if 7rendered is available, 7rendered will shoot the new date at the current rates in effect at the time of the change. If 7rendered is not available on the new date, or if the event is canceled, 7rendered is obligated to refund payments made, less \$500.00 date reservation fee.

Production and Editorial Control: 7rendered will make every effort to give the Client the best audio and video recording possible, but makes no guarantee either expressed or implied, in regard to the quality of audio/video recordings that are subjective and influenced by many factors beyond the complete control of 7rendered, especially during live or unstaged events, like weddings. It is also understood that the client is hiring 7rendered for their technical and artistic expertise and, therefore, 7rendered reserves the right to edit the DVD(s) as they see fit. 7rendered does not guarantee that everyone involved in the event will be videotaped or will be included in the final edited DVD.

Restrictions: The Client is aware that restrictions imposed by others (e.g. photographer, church, reception hall, guests, etc.), and the constraints of the physical environment, safety, weather, and acts of God can affect the quality and extent of video coverage possible. 7rendered guarantees coverage of all events only within the bounds of any restrictions and constraints of the physical environment, safety, weather and acts of God. The Client is responsible for obtaining all permissions and clearances, etc., and adequate shelter from precipitation and extreme temperatures as required for 7rendered to operate.

Property Rights: The Client warrants that he/she has the legal rights to anything 7rendered will videotape, including photos, musical recordings, videotapes, or any other materials delivered to 7rendered for inclusion in The Client's DVD. The Client agrees to indemnify and hold 7rendered harmless for any loss, damage, or liability for infringement of any rights arising from the use or sale of tapes or DVDs The Client hires 7rendered to produce, edit or duplicate. The Client agrees to use the final DVD for private home viewing only.

Model Release: The contracting party grants 7rendered the unrestricted right to use and publish videos and/or photographs of the contracting party for commercial, promotion, competition or other purposes without compensation or liability to the contracting party. It is the responsibility of the client to advise any and/or all participants and attendees that the event will be videotaped. All parties attending the event will therefore be considered as consenting to be included in the final edited video and/or commercial/promotional video by their presence.

Food and Parking: The Client will provide food service in the main reception room for 7rendered staff during the guest meal service. The Client will provide parking for 7rendered's vehicle as close to the event as possible.

Overtime: When ever activities extend beyond the agreed upon length of time of coverage and The Client requests extended coverage, overtime will be billed at \$50.00 every half-hour started, until such time as The Client has departed or informs 7rendered to discontinue. The same rate will be applied to changes requested by the client to the delivered product.

Delivery of DVD: Normal delivery of The Client's DVD is within two to six weeks of the event. This delivery schedule is only approximate, and, among other factors, is dependent on 7rendered having received all production materials supplied by The Client for inclusion in the DVD. An extended delivery schedule necessary for proper completion of the event DVD will not void this contract. Original source footage will remain the property of 7rendered. Delivery of the edited DVD(s) will be upon receipt of the balance due.
